In this kids cooking barbeque contest there are three categories that cost \$20.00 per category. You may enter one or all categories. Upon arrival you will be asked to check-in at the table, you also may be asked for a meat inspection. We ask that all meat be un-prepped, sealed and cold on ice! If meat is warm you will be asked to replace it. The cooking process is planned around YOUR time!

The cutoff date for the entry turn in is May 25, and we have a maximum team number of 25 teams.

I _____ (parent of head cook) agree to let the child cooking work solely on the meat he/she plans to turn in. I realize that I am FULLY responsible for all actions taken in the cooking process, also that I take full responsibility for my child and child's team mates.
